Offering A: Simple Cremation

Local transfer of deceased to our facility, services of licensed personnel and staff, use of facilities and equipment, death notice placed on our website, other preparation of deceased, local use of service car, filing all necessary paperwork for cremation, temporary urn, crematory charge, medical examiner fee and alternative container. **Member \$1250 / Non Member \$1495**

Offering B: Veterans Simple Cremation

Local transfer of deceased to our facility, services of licensed personnel and staff, use of facilities and equipment, death notice placed on our website, arranging military honors, including flag folding detail and taps conducted by military personnel at desired location, American flag, other preparation of deceased, service car, filing all necessary paperwork for cremation, sheet bronze urn with military applique, crematory charge, medical examiner fee and alternative container. **Member \$1350 / Non Member \$1595**

Offering C: Simple Cremation with Private Family Viewing

Local transfer of deceased to our facility, services of licensed personnel and staff, use of facilities and equipment, death notice placed on our website, clinical private family viewing for 10 family members within 24 hours of death at our chapel for up to 30 minutes, other preparation of deceased, service car, filing all necessary paperwork for cremation, temporary urn, crematory charge, medical examiner fee and alternative container. **Member \$1450 / Non Member \$1695**

(In all our offerings above an alternative container is used. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is a pressed wood product, which may be provided by the purchaser, providing it meets the State of New Hampshire's specifications.)

(In all our offerings a discount of \$245.00 is given for becoming a member at no additional cost. Membership form must be in our possession 48 hours prior to member's death.)

A. PROFESSIONAL SERVICES

Basic Services of Licensed Personnel and Staff

Our fee for the services of licensed personnel and staff includes, but is not limited to, staff to respond to initial request for service; preparation and filing of necessary authorizations and permits; recording vital statistics; death notice preparation; staff assistance prior to, during and following the cremation. **\$180**

(This fee for our basic services and overhead will be added to the total cost of the cremation arrangements you select. This fee is already included in our offerings)
